On this date an early morning Law Enforcement Multi-Agency initiative took place in Terrebonne Parish. Beginning at approximately 0430hrs. a series of search warrants and arrests warrants were effected. This Law Enforcement action culminated over 14 months of investigation into an illegal narcotics distribution network operating predominately in the Smithridge area of Terrebonne Parish. Law Enforcement Personnel from several different agencies participated in over 15 search warrants across the parish of Terrebonne. Search warrants were conducted at

The search warrants and included arrest warrants were the result of over fourteen months on investigation by the Terrebonne Narcotics Task Force. Agents initiated a series of Overt actions during the early stages of the investigation, identify street level narcotics violators. Information and intelligence gathered during the early stages, allowed agents to concentrate and conduct covert Operations initiated towards distribution violators. The primary area focused on during the course of this investigation, which was titled "Levee", was the Smithridge area of Terrebonne Parish. This area was designated based on the criminal history of the violators, predominately narcotics and violent crime oriented. TNTF has also received a great many calls for assistance from this area, due to the heavy illegal narcotics trafficking in the area.

The Terrebonne Narcotics Task Force conducted several months of covert operations in the area, gathering enough evidence to proceed with arrest warrants on the defendants. The Terrebonne Narcotics Task Force conducted the series of search warrants simultaneously based on the belief that failure to do so would result in the loss of potential evidence at the locations, if left unsearched.

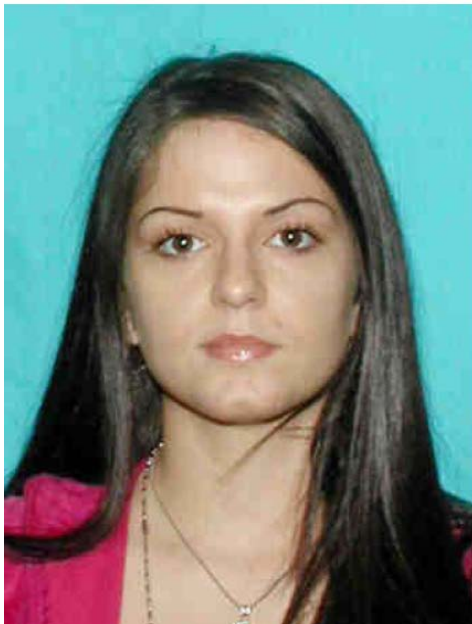
