The Terrebonne Narcotics Task Force executed a series of 25 search warrants and attempted to execute 73 arrest warrants based on illegal narcotics activities. The search warrants and arrest warrants were based on over 24 months of covert investigation by the Terrebonne Narcotics Task Force. Defendants involved in the investigation operated in areas East and West of the inter coastal waterway. Agents with TNTF conducted numerous covert investigations attempting to identify the listed defendants. Agents were assisted during the course of the investigation to include the execution of the search warrants and arrest warrants by members the Louisiana State Police Narcotics Division, St. Mary's Narcotics Division, Drug Enforcement Administration New Orleans Field Division, Louisiana Probation and Parole, the Houma Police Department, and members of Terrebonne Parish Sheriff's Office.
